

2022 ANNUAL REPORT

PURPOSE: The St. Joseph River Basin Commission exists to provide a forum for the discussion, study and evaluation of water resource issues of common concern and foster cooperative planning and coordinated management of the basin's water and related land resources.

The St. Joseph River Basin Commission was created by the Indiana General Assembly in 1988 to address water quality issues in the St. Joseph River and all the lakes and streams that flow to it. The enabling statute of the Commission (IC 14-30-3) was amended in 2018 to expand the scope and powers of the Commission to address flooding as well.

Individual members and their designated representatives are listed on the following page. Quarterly meetings were held at the Schrock Pavilion in Goshen, IN to direct the activities of the Commission. Meeting <u>agendas and minutes</u> are available on our website. Key Projects & Activities

- Water Monitoring Program Completed year-two of biological monitoring across 12 sites; analyzed Elkhart County water quality data and published report including E. coli trends; sponsored USGS gage on Waldron Lake; assisted Steuben County Lakes Council and Indiana Lake Association with monitoring and strategic planning.
- **Regional Water Planning:** Engaged City of Angola, INTERA, and St. Joseph County on potential regional water study; participated in Upper Elkhart River Watershed Management Plan Steering Committee; hosted flood resilience planning meetings in Noble County; sponsored Steuben County Stormwater & Drainage Needs Assessment.
- **Education & Outreach** Hosted the 2022 St. Joseph River Basin Symposium, featuring presentations on public funding for watershed management; sponsored participation in Watershed Leadership Academy; provided presentations for MS4 contractors, Envirothon, colleges, and community groups; contributed to St. Joseph River documentary.
- **Legislation & Advocacy** Participated in Wetlands Task Force completing final report; provided input to state legislators on the Drainage Task Force and Watershed Development Commission legislation.
- Other Member/Partner Support Assisted LaGrange County with drainage benefit apportionment; hosted Juday Creek Task Force and St. Joseph River Watershed Council meetings; facilitated interagency coordination on watershed data, conservation projects, and regulatory guidance.
